Group Applications Guidance

Background

The AXS Recovery Fund has been developed to help people living in Dumfries and Galloway with alcohol or drug misuse issues in their recovery process.

Applications are considered by members of the AXS Recovery Group, and each is considered on its own merits. The panel are keen to support as many groups as possible, but applications must be completed by a member of staff from one of the ROSC partners and must meet some or all of the eligibility criteria.

It is anticipated that grant awards will not exceed £200 - £250 per group except in exceptional individual circumstances.

Eligibility Criteria

- The group must operate in Dumfries and Galloway.
- The application must demonstrate that the award will help the group progress with their recovery.
- All applications must be submitted by a member of staff who has agreed the request to be appropriate.
- All applications must be countersigned by the manager of the organisation completing the application or it will not be considered.
- Applications from groups with their own constitution will not be considered.
- Groups who receive funding must wait <u>six</u> months before reapplying to the AXS Recovery Fund

Outcomes and Recovery Planning

It is essential that the application to the AXS Recovery Fund makes clear links with recovery outcomes. Please give as much information as possible concerning the potential impact of AXS funding on recovery outcomes: this information will form the basis of the future evaluation.

What will be funded?

The panel are keen to encourage groups to be as creative as possible to ensure that they get the most out of the award. You must ensure that the item or activity can be demonstrably linked to group recovery outcomes. Rather than be prescriptive about what AXS will or won't fund, please contact the AXS Partners with your ideas prior to making a full application.
